Conflict Minerals Policy

Future Advanced Manufacture Ltd supports the ending of violence and human rights violations in the mining of minerals from the area known as the "Conflict Region" in the East of the Democratic Republic of Congo (DRC) and surrounding countries.

These Minerals include Cassiterite (Tin), Wolframite (Tungsten), Coltan (Tantalum), Columbite-Tantalite and Gold, plus their derivative metals which include Tin, Tungsten & Tantalum, known collectively as 3TG.

The mining and sale of what is known as 3TG in, but not limited to the DRC and adjoining countries has contributed to the funding of conflicts and in creating a humanitarian crisis.

On July 21 2010 the Dodd-Frank Wall Street reform and Consumer Protection Act was signed by U.S law. Section 1502 of this Act is a disclosure requirement that calls upon companies to determine whether their products contain conflict minerals, by carrying out supply chain due diligence and to report this to the Securities and Exchange Commission (SEC).

We will undertake due diligence with our suppliers including the provision of written statements where applicable, that any purchases of Tin, Tantalum, Tungsten and Gold originate from outside the "Conflict Region".

This Due Diligence will require selected suppliers to:

- 1. Determine which of their products/components contain Tin, Tungsten, Tantalum and/or Gold.
- 2. Identify all of the smelters in their supply chain that supply the 3TG minerals; if they don't source directly from smelters they will be required to pass on our request to their supply chain to be informed of any smelters.

- 3. Make a declaration to Future Advanced Manufacture Ltd that either the products/components that they supply to us:
 - a, Do not contain 3TG minerals as part of their production or functionality

OR

b, If products do contain these minerals they must originate from non-conflict areas or from smelters that have been validated by an independent private sector party to be conflict free.

Future Advanced Manufacture Ltd will not purchase products that contain conflict minerals that directly or indirectly finance or benefit armed groups in the DRC or adjoining countries.

Future Advanced Manufacture Ltd expects its suppliers where applicable to only source minerals from responsible sources.
